Implementation of the reservation for Economically Weaker Sections applicable in the Non Professional PG Courses and withdrawing the BGN Category – Sanctioned – Orders issued

ORDER

As per the U.O read as (1) above, 10% reservation for Economically Weaker Sections is implemented for all courses in the University with the seats categorized as supernumerary seats. Vide the U.O read as (2) above, the reservation under Economically Weaker Sections has been made applicable only to the Keralite Candidates as in the reservation of SC/ST/SEBC etc. with fee applicable to that of State Merit Seats.

Now, the Director, Directorate of Admissions, vide the U.O Note read as (3) above, has informed that, for Non Professional PG courses (enumerated below) 7.5% of the sanctioned seats are already reserved for Backward General (BGN) as supernumerary seats.

1. MA Applied Economics (1BGN Seats)
2. MA Hindi Languages and Literature (2 BGN Seats)
3. MSc in Mathematics (2 BGN Seats)
4. MSc in Chemistry (2 BGN Seats)
5. MSc in Statistics (2 BGN Seats)
6. MSc in Physics (2 BGN Seats)

The Director, Directorate of Admissions has requested to clarify whether or not to provide seats under "EWSs" Category in addition to "BGN" reservation for the above referred Non Professional PG courses or to provide only the "Economically Weaker Sections" reservation from 2020 admissions onwards.

Considering the above, the Vice-Chancellor has issued orders that since both reservations (EWSs and BGN) are for economically backwards among the "General Category" reservation under "Economically Weaker Sections category (10%)" may alone be retained from 2020 admission onwards, withdrawing the "Economically Backward Class among Forward Caste (BGN) Category (7.5%)" reservation so far given to the Non-Professional PG Programmes, subject to ratification by the Syndicate.

Orders are issued accordingly.
