NOTICE

The School of Legal Studies intends to conduct SPOT ADMISSION to the vacant seats of 3 YEAR LLB (Evening-Academic) Programme. This will be conducted on **22-09-2022** (Friday), at the School of Legal Studies, CUSAT, Cochin 682022. Interested Candidates included in the rank list (CAT 2022) published for admission to 3 YEAR LLB (Evening-Academic) PROGRAMME of CUSAT shall appear for admission on the day. **Registration closes on 10.30 AM.** Spot admission are based on the spot admission rules of the University and **those who do not report after the stipulated time will not be considered for admission on that day, under any circumstances. Candidates without a valid CAT Rank may also appear for the Spot Admission process. Candidates without CAT Rank will be considered only in the absence of CAT ranked candidates in the respective category excluding SC/ST Supernumerary vacancies.**



INSTRUCTIONS TO CANDIDATES

- 1. Eligibility for admission to 3 Year LLB (Academic-Evening) programme: The candidate shall have a minimum of 50% of marks in aggregate in the qualifying degree examination. Candidates belonging to Scheduled Castes, Scheduled Tribes are eligible for 5% relaxation in qualifying marks. 5% relaxation in qualifying marks is given to SEBC candidates applying for Three year LL.B (such candidates should produce proof of their category).**
- 2. Candidates should report in person on 22.09.2022. Registration closes at 10.30Am. Those who do not report before the stipulated time will not be considered for admission on that day, under any circumstances.**
- 3. Admitted Candidates should be ready to pay the fee on the same day itself.**
- 4. Candidates who have taken admission earlier may participate in spot admission if they wish to change their seat category.**
- 5. Candidates who wish to correct any wrong entries in their name, date of birth, caste and community should request for the same with proof at the time of registration itself.**
- 6. Candidates in the rank list who wish to apply under NRI Quota afresh can also be registered. Such candidates, if allotted, shall ready to pay the fees applicable for NRI category including NRI application fee. Fresh candidates under NRI Quota will be considered only after the existing NRI candidates in the rank list.**
