1. General Instruction

The first Real Time Admission to **M.Voc Banking & Finance Programme** offered by DDU KAUSHAL Kendra, CUSAT is scheduled to be conducted on **10.07.2026 (Friday)** at DDU KAUSHAL Kendra (Near SMS building, Top floor of the Applied Economics Building) in the Thrikkakara Main campus. Eligible candidates, in the CUSAT CAT Rank list, who are desirous to take admission, should report for the Real Time Admission without fail. Those candidates who have already taken admission in All India Quota seat and wish for conversion to General Seat should also report for the real time admission.

The registration for real time Admission is from 09:00 AM to 10:00AM. Candidates reporting after 10:00 AM shall not be considered for Real Time Admission on 10.07.2026.
