1. General Instruction

The **SECOND** Real Time Admission (**CAT and Non-CAT**) to **M.Voc Programmes** offered by DDU KAUSHAL Kendra, CUSAT is scheduled to be conducted on **17.07.2026 (Friday)** at DDU KAUSHAL Kendra (Near SMS building, Top floor of the Applied Economics Building) in the Thrikkakara Main campus. Eligible candidates, who are desirous to take admission, should report for the Real Time Admission without fail. Those candidates who have already taken admission in All India Quota seat and wish for conversion to General Seat should also report for the real time admission.

Those candidates who are having a valid CAT rank of CUSAT will be given priority for admission. Candidates who did not apply for CAT will be considered subject to eligibility after considering all the qualified candidates in the CAT rank list. Separate rank list will be prepared for Non-CAT candidates considering the marks secured in qualifying examinations.

Candidates reporting after the mentioned time shall not be considered for Real Time Admission on 17.07.2026.
