Second Real Time Admission Announcement

1. The **Second Real Time Admission for those candidates included in the CAT 2026 rank list/ CUET rank list** published for admission to the Two Year LL.M. Programme of School of Legal Studies, CUSAT is scheduled as follows:

**Date of Real time admission and Registration Time:
28 July 2026 (Tuesday), 9.00 a.m. to 10 a.m.**

- Candidates reporting after 10.00 am shall not be considered for admission.
- The candidates can report in person before the **DIRECTOR, School of Legal Studies, CUSAT with all original documents.**
- Allotted Candidates must be ready to pay the fee on the same day itself.
- Candidates who are admitted through Real Time Admission are required to upload scanned copies of all their original certificates to the Admission Portal via their CAT Login profile. Therefore, candidates are advised to keep the scanned copies of all certificates ready for uploading (if admitted).

The Real Time Admission will be conducted adhering to the Real Time Admission Rules of CUSAT.

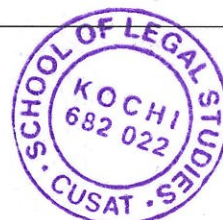
