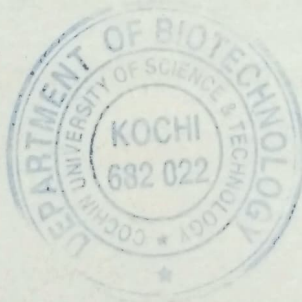

 - Plus2 Marklists and Pass certificate(CBSE,ICSEetc.).
 - Certificate to prove Keralite Status,for StateMeritSeats
 - Transfer Certificate and Conduct Certificate from the Institution last attended(in English version)

- Two passport size Photographs of the candidate
- Aadhar Card
- Community and Non-Creamy Layer certificate in the case of 'SEBC' candidates.
- Community certificate issued by the Tahsildar in the case of Kerala Scheduled Caste(KSC)/ Kerala Scheduled Tribe (KST) candidates.
- Candidates seeking admission under Physically challenged(PHC) category should invariably produce a valid Physically Handicapped certificate issued by the District Medical Board of the State to which the candidate belongs.
- If any of the above certificates are not in English/Malayalam, Candidates should invariably produce a translated version of the same in English endorsed by a Notary Public.
- One set of self-attested copies of all the original certificates/documents mentioned above.
- NRI status is not compulsory but those who have opted for NRI seats should submit the 'Declaration' given in **Annexure I**.
- **Note:** Students who have already opted NRI status at the time of CAT registration will be preferred first.

The candidate who got admission should remit the required fee on the same day. The payment is to be done through Online only.
