1. CAT-2026 Admit Card (**Original**).
2. Migration Certificate (for students from outside Kerala state)
3. S.S.L.C/10th Mark list & pass certificate (CBSE, ICSE etc.).
4. Degree Consolidated Mark list and **original** Degree/Provisional certificate.
5. Certificate to prove Keralite Status, for State Merit Seats (Birth Certificate/Nativity Certificate).
6. Transfer Certificate and Conduct Certificate (**original**) from the Institution last attended (in English version)
7. Four passport size Photographs of the candidate.
8. Community and Non-Creamy Layer certificate in the case of 'SEBC' candidates.
9. Community certificate issued by the Tahsildar in the case of Kerala Scheduled Caste (KSC)/Kerala Scheduled Tribe (KST) candidates.
10. PHC/DAC/IDC Candidates should invariably produce a valid certificate issued by the District Medical Board of the State to which the candidate belongs.
11. Two sets of self-attested copies of all the original certificates/documents mentioned above.
12. NRI status is not compulsory but those who have opted for NRI seats should submit the 'Declaration' given in **Annexure I**.
