1. CAT-2026 Admit Card (**Original**).
2. Migration Certificate (for students from outside Kerala state)
3. S.S.L.C/10th Mark list & pass certificate (CBSE, ICSE etc.).
4. Degree Consolidated Mark list and **original** Degree/Provisional certificate.
5. Certificate to prove Keralite Status, for State Merit Seats (Birth Certificate/Nativity Certificate).
6. Transfer Certificate and Conduct Certificate (**original**) from the Institution last attended (in English version)
7. Four passport size Photographs of the candidate.
8. Community certificate issued by the Tahsildar in the case of Kerala Scheduled Caste (KSC)/Kerala Scheduled Tribe (KST) candidates.
9. PHC/DAC/IDC Candidates should invariably produce a valid certificate issued by the District Medical Board of the State to which the candidate belongs.
10. Two sets of self-attested copies of all the original certificates/documents mentioned above.
11. NRI status is not compulsory but those who have opted for NRI seats should submit the 'Declaration' given in **Annexure I**.
