1. CAT-2025 Admit Card/Online application Registration Confirmation Page.
2. Migration Certificate (for students from outside Kerala state)
3. S.S.L.C/10th Mark list & pass certificate (CBSE, ICSE etc.).
4. Plus 2 Mark lists/ and pass certificate (CBSE, ICSE etc.).
5. Certificate to prove Keralite Status, for State Merit Seats
6. Transfer Certificate and Conduct Certificate (original) from the Institution last attended (in English version)
7. Four passport size Photographs of the candidate.
8. Community and Non-Creamy Layer certificate in the case of 'SEBC' candidates.

9. Community certificate issued by the Tahsildar in the case of Kerala Scheduled Caste (KSC)/Kerala Scheduled Tribe (KST) candidates.
10. Candidates seeking admission under physically challenged (PHC) category should invariably produce a valid Physically Handicapped certificate issued by the District Medical Board of the State to which the candidate belongs.
11. If any of the above certificates are not in English/Malayalam, Candidates should invariably produce a translated version of the same in English endorsed by a Notary Public.
12. Two sets of self-attested copies of all the original certificates/documents mentioned above.
13. NRI status is not compulsory but those who have opted for NRI seats should submit the 'Declaration' given in Annexure I.
