1. General Instruction

The fifth Real Time Counselling to B.Voc (Hons.) Data Science and Analytics Programme offered by DDU KAUSHAL Kendra, CUSAT is scheduled to be conducted on 09.09.2026 (Wednesday) at DDU KAUSHAL Kendra (Near SMS building, Top floor of the Applied Economics Building) in the Thrikkakara Main campus, as per the order of the Hon'ble Vice Chancellor. Eligible candidates, who are desirous to take admission, with CAT 2026 rank (range mentioned below) can attend same as scheduled below.

The registration for real time Counselling is from 09:00 AM to 10:00 AM. Candidates reporting after 10:00 AM shall not be considered for Real Time Counselling. Individual call letter will not be sent to the candidates. So all those who are interested in the programme within the rank range mentioned should report for the Real Time counselling without fail.
