The registration process will end at 10.30 AM. The selected candidates must pay the fee on the same day to ensure their admission.

- Only General seats will be filled from non-CAT candidates. Supernumerary seats will be filled from CAT rank list only.
- Candidates without a valid CAT Rank can also attend the real time admission. Preference will be given to candidates with CAT rank and others will be considered only in the absence of the candidates with a valid CAT Rank.

- Non CAT candidates are required to pay the prescribed application fee in addition to the above fee.
- Fees shall be paid only through online mode. No cash payments will be accepted.
- In the absence of the eligible SC/ST candidates, candidates coming under OEC(SC) / OEC(ST) category shall be considered for admission.
- CUET candidates must be from the CUET ranklist published by CUSAT.

Documents in original (with two sets of self attested copies) of the following documents should be produced for verification at the time of admission.

1. CAT-2026 Admit Card/Online application Registration Confirmation Page.
2. Migration Certificate (for students from outside Kerala state)
3. S.S.L.C/10th Mark list & pass certificate (CBSE, ICSE etc.).
4. Plus 2 Mark lists/ and pass certificate (CBSE, ICSE etc.).
5. Degree Certificate and Marklists
6. Certificate to prove Keralite Status, for State Merit Seats
7. Transfer Certificate and Conduct Certificate (original) from the Institution last attended (in English version)
8. Four passport size Photographs of the candidate.
9. Community and Non-Creamy Layer certificate in the case of 'SEBC' candidates.
10. Community certificate issued by the Tahsildar in the case of Kerala Scheduled Caste (KSC)/Kerala Scheduled Tribe (KST) candidates.
11. Candidates seeking admission under physically challenged (PHC) category should invariably produce a valid Physically Handicapped certificate issued by the District Medical Board of the State to which the candidate belongs.
12. If any of the above certificates are not in English/Malayalam, Candidates should invariably produce a translated version of the same in English endorsed by a Notary Public.
13. Two sets of self-attested copies of all the original certificates/documents mentioned above.
14. NRI status is not compulsory but those who have opted for NRI seats should submit the 'Declaration' given in **Annexure I**.
