



### **Real Time Admission Notice**

IUCIPRS will conduct final Realtime admission for Two-year LLM (IPR) programme on **18.09.2026**

- **Those who are not in the rank list of CAT 2026 can also participate in the spot.** But preference will be given to those in the CAT 2026 rank list for Two-year LLM (IPR) programme
- **Eligibility:** Pass in Bachelor's Degree in Law with a minimum of 50% or equivalent CGPA Grade, from any University of Kerala or an examination of any other recognised University/Institution. Candidates belonging to SC/ST category are eligible for concession admissible under the orders of the Government.
- **Registration Time: 09.30 am to 10.30 am.** Late candidates will not be allowed to attend the real time admission process.
- **Vacancy Position -Five** (General and reservation seats) **and one SC vacancy** - Detailed split up will be published on 17.09.2026
- If there are no candidates belonging to reservation category, seats reserved for them (other than seats reserved for KSC) will be converted to general seats in the second round of admission.
- If there are no SC/ST candidates the seats will be allotted to those SC-OEC/ST-OEC candidates who are in the CAT 2026 rank list for Two-year LLM (IPR) programme in the second round of admission
- **Fee structure:**

- In addition to the above selected candidates need to remit PTA fees of Rs.3,000/-, Alumni fee of Rs.800/- and Departmental Development Fund fee of Rs.2,000/- on the same day

- Those who get allotment in real time admission are required to **pay the fees (online only) on 18.09.2026 itself**, failing which their admission will be cancelled.
- Candidates are advised to keep PDF copies of their certificates on their mobile phones for uploading them to the admission portal.
